

Mauritius Finance Scholarship Scheme 2022

Applications are invited from candidates who would like to be considered for the award of scholarships under Mauritius Finance Scholarship Scheme 2022, to pursue a career in the financial services sector in Mauritius. This scholarship scheme is aimed at HSC leavers, providing access to equal opportunities within the financial services sector, and to build capacity within the industry.

Priorities will be given to students who come either from a family registered under the Social Register of Mauritius or from vulnerable groups as defined by the National CSR Foundation Charter 2017.

Mauritius Finance is envisaging to award 20 scholarships starting in February 2022.

1. Overview

The scholarship project will be for a duration of six months whereby the applicant will follow a Certificate course while being simultaneously on a placement. The Certificate course will be dispensed by an international training partner through a structured online course.

2. The Certificate Course

The course will be either:

- o a Certificate in Anti Money Laundering dispensed by the International Compliance Association (ICA), in association with Alliance Manchester Business School, the University of Manchester.
- o or a Certificate in Fund Administration and Accounting dispensed by CLT International, in association with Alliance Manchester Business School, the University of Manchester.

The course must be completed with a period of five months.

3. Placement

In parallel with the course, the applicant will be on placement with our member firms (hereafter referred to as "employer") and latter will pay a monthly stipend to the applicant for the duration of the placement. The employer will have the independence to confirm the employment of the applicant at the end of the placement, subject to satisfactory performance. Once hired, the employer will also undertake to sponsor further tertiary or professional qualification for the applicant.



4. Eligibility and Conditions for the Scholarship

a. Applicant should have earned a minimum of 21 points at HSC/GCE 'A' Level, secured at one and same sitting and computed based on the following grade obtained for Advanced Level subjects:

$$A+=10$$
, $A=9$, $B=8$, $C=7$, $D=6$ & $E=5$, or an equivalent acceptable qualification.

- b. The scholarship is aimed at residents of mainland Mauritius. Applicants from Rodrigues and the Outer Islands unless already resident in mainland Mauritius, would not be eligible to apply.
- c. The applicants should not be beneficiaries of any other grant or scholarships.
- d. The applicants should undertake to complete the scheme within the required timeframe.
- e. The applicants should not be more than 25 years old.
- f. Should be unemployed on date of submission of application.

5. Application Procedure

- a. Application must be made on the prescribed form available at the office of Mauritius Finance, First Floor, Atal Bihari Vajpayee Tower, Ebene or herewith annexed with this advert.
- b. Copies of documents to be submitted together with completed Application form:
 - 1. Birth certificate of applicant.
 - 2. National Identity Card of applicant.
 - 3. Educational Certificates (HSC/GCE Advanced Level) or equivalent.
 - 4. Letter of Motivation
 - 5. Proof of address (copy of a recent utility bill, less than 3 months old).
 - 6. Testimonials from two referees, who know the candidate personally. At least one of the referees must be familiar with the academic record of the candidate.
 - 7. Evidence from the Ministry of Social Security that applicant comes either from a family registered under the Social Register of Mauritius or from vulnerable groups as defined by the National CSR Foundation Charter 2017 (where applicable).

6. Termination of Scholarship

The scholarship may be terminated in the event a scholarship holder fails to complete the for reasons of performance, or conduct, before the expiry of the duration of the programme.

7. Selection



- o Eligible candidates will be called for interview (if required) after a shortlisting exercise.
- o Candidates are reminded that no application will be considered in absentia and that they should be present for the interview.
